VOTE: I move favorable action on Article 28 and Article 29 Fund Kingston Town Employee Labor and Clerical Union Contracts and approve as amended.

A discussion was held regarding the moving of Articles 28 and 29, and the decision was to have Mr. Alcombright move the articles at Town Meeting.
