1. 5:30 Continuation of Public Hearing - Discussion of Department of Public Works

The Kingston Board of Selectmen will hold a public hearing on Tuesday, June 17, 2025, at 5:30 p.m. at the Kingston Town House, 26 Evergreen Street, Kingston, MA. The purpose of the hearing is to gather resident comments regarding the proposed creation of a Public Works Department.

At the 2025 Annual Town Meeting, a warrant article to establish a Public Works Department, consolidating the operations and staff of the Highway, Water, and Sewer Departments did not pass. Several residents expressed concern that there was insufficient opportunity to review and discuss the proposal ahead of the vote. In response, the Board of Selectmen is scheduling a series of public hearings to invite community input before potentially resubmitting the article at a future Town Meeting.
